NOTIFICATION

Applications are invited from qualified Indian Citizens for appointment to the post of Plumber/Pump Operator in the High Court of Kerala. Applications should be submitted in the prescribed format which is available in the website (www.hckrecruitment.nic.in) and notice board of the High Court. Applications in the prescribed format prepared on good quality A4 size paper in accordance with the instructions in this notification should be sent to the High Court by post.

1. **Recruitment No.** : 05/2012
2. **Name of the Post** : Plumber/Pump Operator
3. **Scale of pay** : ₹ 9190-15,780/-
4. **Number of vacancies** :1(One). Vacancies that may arise during the period of validity of the ranked list shall also be filled up from the list. The ranked list prepared pursuant to this notification shall remain in force for a minimum period of two years from the date on which it is brought into force and shall continue to remain in force until the publication of a fresh list or till the expiry of three years, whichever is earlier.
5. **Method of appointment:** Direct Recruitment.
6. **Mode of Selection:** Selection shall be made on the basis of written test or interview or both having regard to the number of candidates.
7. **Age limit:** Candidates should have been born between 02.01.1977 and 01.01.1994 (both days inclusive). The upper age limit shall be raised by five years in the case of candidates belonging to Scheduled Castes or Scheduled Tribes and by three years in the case of candidates belonging to the Other Backward Classes. A candidate who is an Ex-serviceman or Ex-general Reserve Engineer Force person or a disembodied Territorial Army person, in reckoning the age for his eligibility for appointment, can exclude the period of his service in the defence forces or in the General Reserve Engineer force or in the Territorial Army, as the case may be, and the period of unemployment on discharge up to a maximum of five years, provided he has not completed the age of 50 years.
8. **Qualification:** 1. S.S.L.C. or equivalent 2. National Trade Certificate in the trade of Plumber 3. Experience of atleast 2 years as Plumber/Pump Operator.
Note:- Physically Handicapped persons and women are not eligible to apply.
9. **Application fee:** ₹200/-. SC/ST candidates are exempted from payment of fee. The fee should be remitted by way of Demand Draft drawn on any of the Nationalised Banks in favour of "Registrar General, High Court of Kerala" payable at Ernakulam. The candidates should write their name and address on the reverse of the Demand Draft and send it along with the application. Fee once paid will not, in any case, be refunded.

10. Appointment to the post from the Ranked List prepared as per this notification will be made in accordance with rules of reservation prescribed in Rules 14 to 17 of Part II of the Kerala State and Subordinate Services Rules, 1958 and in accordance with the rules made for the purpose from time to time.
11. Candidates should send along with the application self attested copies of S.S.L.C., National Trade Certificate in the trade of Plumber and Experience certificate to prove their qualification and experience. Failure to produce proof of qualification and experience will entail rejection of application.
12. Documents to prove age, community, Non Creamy Layer status, claim for exemption from payment of application fee etc. should be produced as and when called for.
13. Candidates should affix their passport size photograph (taken within the last 6 months) at the space provided for in the application form and sign across it. Applications received without signature on the photograph affixed will be rejected.
14. The candidate should ensure that the particulars furnished by him/her are correct in all respects. In case it is detected at any stage of recruitment that a candidate does not fulfil the eligibility norms and/or that he/she has furnished any incorrect/false information or has suppressed any material facts, his/her candidature will stand cancelled. If any of these shortcomings is detected even after appointment, his/her service is liable to be terminated.
15. The envelope containing the application shall be superscribed "Application for the post of Plumber/Pump Operator" and sent to "The Registrar General, High Court of Kerala, Ernakulam, Kochi-682 031".

16. Last date for receipt of applications: 24.05.2012

17. Applications which are not in accordance with this notification and received after the last date prescribed shall be summarily rejected.
18. **Admission Ticket:-** If it is decided to hold written test for selection, Admission ticket will not be sent by post. Candidates have to download their Admission Ticket for the Test from the website "hckrecruitment.nic.in". The Admission tickets will be ready for download from three weeks before the date of test and the matter will be informed through Press Release and through SMS in the case of candidates, who have provided their mobile number in the application. The candidates are also advised to visit the website of the High Court at least two weeks to know about the date of the test.
