**ORDER NO. B1 – 85 / 2013**

As part of filling up the existing vacancies of Sheristadars and Senior Superintendents of the Subordinate Judiciary, the following orders are issued:

1. V. Kumaran, Sheristadar, District Court Palakkad, is transferred and posted as Sheristadar, District Court, Kasaragod. He will handover charge of his office to the Senior Superintendent / Junior Superintendent of the Court and take charge as Sheristadar, District Court Kasaragod from the Senior Superintendent / Junior Superintendent of the Court.

6. Sri.K.Jayachandran, Sheristadar,Wakf Tribunal, Kozhikode is promoted as Sheristadar, Addl. District Courts / Motor Accidents Claims Tribunals / Spl. Courts under Rule 4 (a) of the Kerala Judicial Ministerial Service Rules, 2006 in the scale of Pay of ₹ 21240 - 37040 and posted as Sheristadar, Spl Court ( NDPS Act cases) / Additional District Court , Vadakara. He will handover charge of his office to the Junior Superintendent / Head Clerk of the Court and take charge as Sheristadar, Sub Court, Chengannur from the Junior Superintendent / Head Clerk of the court.

The Junior Superintendent / Head Clerk of the Sub Court, Thiruvalla will hold the full additional charge of the post of the Sheristadar of the court till Sri. M. Vijankumar(Sl.No.10) takes charge.

9. Sri. P. Sreekumar, Senior Superintendent, District Court, Manjeri is transferred and posted as Senior Superintendent, District Court, Alappuzha. He will handover charge of his office to the Junior Superintendent / Head Clerk of the Court and take charge as Senior Superintendent, District Court, Alappuzha from the Junior Superintendent/Head Clerk of the court.

The Junior Superintendent / Head Clerk of the District Court, Manjeri will hold the full additional charge of the post of the Sheristadar of the court till Sri. Radhakrisna Kurup .C.K, (Sl.No.16) takes charge.

10. Sri. M. Vijankumar, Sheristadar, Sub Court, Pala is transferred and posted as Sheristadar, Sub Court, Thiruvalla. He will handover charge of his office to the Junior Superintendent / Head Clerk of the Court and take charge as Sheristadar, Sub Court, Thiruvalla from the Junior Superintendent/Head Clerk of the court.

The Junior Superintendent / Head Clerk of the Sub Court, Pala will hold the full additional charge of the post of the Sheristadar of the court till Sri. Benny Thomas, (Sl.No13.) takes charge.

11. Sri. Raju. C, Sheristadar, Sub Court, Sulthan Bathery is transferred and posted as Senior Superintendent, District Court, Kasaragod. He will handover charge of his office to the Junior Superintendent / Head Clerk of the Court and take charge as Senior Superintendent, District Court, Kasaragod from the Junior Superintendent / Head Clerk of the court.

The Junior Superintendent / Head Clerk of the Sub Court, Sulthan Bathery will hold the full additional charge of the post of the Sheristadar of the court till Sri. George.K. Jose, (Sl.No.22 ) takes charge.

12. Smt. A.A. Zeenath, Sheristadar, Sub Court, Alappuzha is transferred and posted as Senior Superintendent, District Court, Ernakulam . The officers at Sl. Nos. 3, 4, 8, 9,10,11,12 and 13 are not eligible for joining time and transfer TA. The officer at Sl. No. 1 is not eligible for joining time.
