Judiciary – Posting of newly appointed temporary Munsiff-Magistrates in the Subordinate Judiciary - Orders issued.

Read : GO(Ms)No. 208/2013/Home dated 24-08-2013

ORDER NO. B1 – 42183/2013

As per the GO read above, the Government have appointed 21 officers as Temporary Munsiff-Magistrates in the Kerala Judicial Service. In the circumstances the following transfers and postings in the State Subordinate Judiciary are ordered :

1. Smt. Sunitha K.P., Munsiff, Payyannur is transferred and posted as Munsiff, Nadapuram. She will handover charge of her office to Smt. Annamma John V (Sl.No.14) and take charge as Munsiff, Nadapuram from the Judicial Magistrate of First Class, Nadapuram.

2. Shri K.Shine, Munsiff, Muvattupuzha is posted as Judicial Magistrate of First Class, Muvattupuzha. He will hand over charge of his office to Smt. Sunitha S. (Sl.No.17) and assume charge as Judicial Magistrate of First Class, Muvattupuzha.

3. Smt. Ambili C.S., Addl.Munsiff-II, Neyyattinkara is posted as Judicial Magistrate of First Class-II, Neyyattinkara. She will handover her office to Shri.V.J.Alexander(Sl.No.26) and take charge as Judicial Magistrate of First Class-II, Neyyattinkara from Shri Jacob C.John(Sl.No.10)

4. Smt.Naina K.V., Munsiff, Punalur is posted as Judicial Magistrate of First Class-II(Forest Offences), Punalur. She will hand over charge of her office to Smt. Manju Manaswini(Sl.No.19) and take charge as Judicial Magistrate of First Class-II (Forest Offences), Punalur from the Judicial Magistrate of First Class-I, Punalur.

5. Shri Sandeep Krishna V., Munsiff, Idukki is posted as Judicial Magistrate of First Class, Idukki. He will handover charge of his office to Shri M.Aravindakshan (Sl.No.24) and assume charge as Judicial Magistrate of First Class, Idukki. He will also handover his additional charge of Judicial Magistrate of First Class, Nedumkandam to Shri Sabu M.N.(Sl.No.28)

6. Smt. Leena Rasheed, Munsiff-Magistrate, Paravoor is transferred and posted as Judicial Magistrate of First Class, Chalakkudy. She will handover charge of her office to Shri Soman P.Mamkuttathil(Sl.No.9) and take charge as Judicial Magistrate of First Class, Chalakkudy from the Chief Judicial Magistrate, Thrissur.

7. Shri M.Rajappan Nair, Munsiff, Kalpetta is transferred and posted as Munsiff, Pathanamthitta. He will handover charge of his office to Shri Satheesan T. (Sl.No.27) and take charge as Munsiff, Pathanamthitta from the Judicial Magistrate of First Class-II, Pathanamthitta.

8. Smt. P.D.Jyothi, Additional Munsiff, Nedumangad is posted as Judicial Magistrate of First Class(Forest Offences), Nedumangad. She will handover charge of her office to Shri Harikumar T.G.(Sl.No.18) and take charge as Judicial Magistrate of First Class(Forest Offences), Nedumangad from the Judicial Magistrate of First Class-I, Nedumangad.

9. Shri Soman P.Mamkuttathil, Judicial Magistrate of First Class, Thaliparamba is transferred and posted as Munsiff-Magistrate, Paravur. He will handover charge of his office to Shri Karunakaran N.(Sl. No.31) and take charge as Munsiff-Magistrate, Paravur from Smt. Leena Rasheed(Sl.No.6)

10. Shri Jacob C. John, Judicial Magistrate of First Class-II, Neyyattinkara is transferred and posted as Judicial Magistrate of First Class-IV(Mobile Court), Thiruvananthapuram.He will handover charge of his office to Smt.Ambili C.S.(Sl.No.3) and take charge as Judicial Magistrate of First Class-IV(Mobile Court), Thiruvananthapuram from the Judicial Magistrate of First Class-II, Thiruvananthapuram

11. Shri Aneesh M.D, Assistant Public Prosecutor Gr.II, JFCMC-I, Peermade who stands appointed as temporary Munsiff-Magistrate as per GO cited above is posted as Judicial Magistrate of First Class-II(Mobile Court), Kozhikode. On relief from his present post, he will take charge as Judicial Magistrate of First Class-II (Mobile Court), Kozhikode from the Judicial Magistrate of First Class-I, Kozhikode.

12.Shri M.S.Mohanachandran Nair, Sr.Gr. Legal Assistant, Law Dept.,Govt. Of Kerala who stands appointed as temporary Munsiff-Magistrate as per GO cited above is posted as Additional Munsiff, Kasaragod. On relief from his present post, he will take charge as Additional Munsiff, Kasaragod from the Principal Munsiff, Kasaragode

13. Smt. Sai Vani K.R, Section Officer / Court Officer, High Court of Kerala who stands appointed as temporary Munsiff-Magistrate as per GO cited above, is posted as Additional Munsiff, Kochi. On relief from her present post, she will take charge as Additional Munsiff, Kochi from the Principal Munsiff, Kochi.

14. Smt. Annamma John V, Sheristadar, District Court, Kasaragod who stands appointed as temporary Munsiff-Magistrate as per GO cited above, is posted as Munsiff, Payyannur. She will handover charge of her office to the Senior Superintendent / Junior Superintendent of the court and take charge as Munsiff, Payyannur from Smt. Sunitha K.P.(Sl.No.1)

15. Shri P.A.Shamsudeen, Sheristadar, Sub Court, Kochi who stands appointed as temporary Munsiff-Magistrate as per GO cited above, is posted as Munsiff-Magistrate, Devikulam. He will handover charge of his office to the Junior Superintendent / Head Clerk of the court and take charge as Munsiff-Magistrate, Devikulam from the Judicial Magistrate of First Class, Adimaly.

16. Shri V.S.Jyothilal Prasad, Section Officer(Hr.Gr.) / Court Officer(Hr.Gr.), High Court of Kerala who stands appointed as temporary Munsiff-Magistrate as per GO cited above, is posted as Munsiff, Ranni. On relief from his present post, he will take charge as Munsiff, Ranni from the Judicial Magistrate of First Class, Ranni.

17.Smt. Sunitha S, Section Officer / Court Officer, High Court of Kerala who stands appointed as temporary Munsiff-Magistrate as per GO cited above, is posted as Munsiff, Muvattupuzha. On relief from her present post, she will take charge as Munsiff, Muvattupuzha from Shri K.Shine(Sl.No.2)

18.Shri Hari Kumar T.G, Head Clerk, MACT, Pathanamthitta who stands appointed as temporary Munsiff-Magistrate as per GO cited above, is posted as Additional Munsiff, Nedumangad. On relief from his present post, he will take charge as Additional Munsiff, Nedumangad from Smt. P.D.Jyothi(Sl.No.8)

19. Smt. Manju Manaswini V.R, Section Officer, Law Department, Government Secretariat, Thiruvananthapuram who stands appointed as temporary Munsiff-Magistrate as per GO cited above, is posted as Munsiff, Punalur. On relief from her present post, she will take charge as Munsiff, Punalur from Smt.Naina K.V. (Sl.No.4)

20. Shri Sekharan Kutty R, Junior Superintendent, JFCMC, Alathur who stands appointed as temporary Munsiff-Magistrate as per GO cited above, is posted as Judicial Magistrate of First Class-II(Forest Offences), Manjeri. On relief from his present post, he will take charge as Judicial Magistrate of First Class-II(Forest Offences), Manjeri from the Judicial Magistrate of First Class-I, Manjeri.

21. Shri Joseph P.Y, Junior Superintendent, JFCM Court, Irinjalakuda who stands appointed as temporary Munsiff-Magistrate as per GO cited above, is posted

as Judicial Magistrate of First Class-III(Mobile Court), Ernakulam. On relief from his present post, he will take charge as Judicial Magistrate of First Class-III(Mobile Court), Ernakulam from the Judicial Magistrate of First Class-II, Ernakulam.

22. Shri Balakrishna Patinharath, Senior Superintendent, District Court, Kalpetta who stands appointed as temporary Munsiff-Magistrate as per GO cited above, is posted as Judicial Magistrate of First Class, Mananthavady. He will handover charge of his office to the Junior Superintendent / Head Clerk of the court and take charge as Judicial Magistrate of First Class, Mananthavady from the Munsiff-Magistrate, Mananthavady.

23. Shri Samkumar Raghavan, Assistant Public Prosecutor Gr.I, Munsiff-Magistrate Court Devikulam who stands appointed as temporary Munsiff-Magistrate as per GO cited above, is posted as Judicial Magistrate of First Class-I, Ernakulam. On relief from his present post, he will take charge as Judicial Magistrate of First Class-I, Ernakulam from the Judicial Magistrate of First Class-II, Ernakulam.

Shri M.Aravindakshan, Section Officer(Hr.Gr.) / Court Officer(Hr.Gr.), High Court of Kerala who stands appointed as temporary Munsiff-Magistrate as per GO cited above, is posted as Munsiff, Idukki. On relief from his present post, he will take charge as Munsiff, Idukki from Sri. Sandeep Krishna. V (sl No. 5)

25. Shri Sasikumar. K, U.D.Clerk(Hr.Gr.)CJM Court, Ernakulam who stands appointed as temporary Munsiff-Magistrate as per GO cited above, is posted as Munsiff, Kayamkulam. On relief from his present post, he will take charge as Munsiff, Kayamkulam from the Judicial Magistrate of First Class, Kayamkulam.

26 Shri V.J.Alexander, Sheristadar, Addl.District & Sessions Court for the trial of cases relating to atrocities and sexual violence against women and children , Ernakulam who stands appointed as temporary Munsiff-Magistrate as per GO cited above, is posted as Additional Munsiff-II, Neyyattinkara. He will hand over charge of his office to the Junior Superintendent / Head Clerk of the court and take charge as Additional Munsiff-II, Neyyattinkara from Smt. Ambili C.S.(SI.No.3)

27. Shri Satheesan. T, U.D.Clerk, Family Court, Vadakara who stands appointed as temporary Munsiff-Magistrate as per GO cited above, is posted as Munsiff, Kalpetta. On relief from his present post, he will take charge as Munsiff, Kalpetta from Shri M.Rajappan Nair M.(SI.No.7).

28.Shri Sabu.M.N, Assistant Public Prosecutor Gr.II, JFCMC-II, Aluva who stands appointed as temporary Munsiff-Magistrate as per GO cited above, is posted

as Judicial Magistrate of First Class, Nedumkandam. On relief from his present post, he will take charge as Judicial Magistrate of First Class, Nedumkandam from Shri Sandeep Krishna V.(Sl.No.5)

29. Shri E.Shajahan, Head Clerk(H.G), District Court, Pathanamthitta who stands appointed as temporary Munsiff-Magistrate as per GO cited above, is posted as Judicial Magistrate of First Class, Kasaragode. On relief from his present post, he will take charge as Judicial Magistrate of First Class, Kasaragode from the Chief Judicial Magistrate, Kasaragode

30. Shri T.K.Anirudhan, Assistant Section Officer, High Court of Kerala who stands appointed as temporary Munsiff-Magistrate as per GO cited above, is posted as Additional Munsiff-II, Thiruvananthapuram. On relief from his present post, he will take charge as Additional Munsiff-II, Thiruvananthapuram from the Additional Munsiff-III(RCC), Thiruvananthapuram

31. Shri Karunakaran N, Junior Superintendent, Munsiff Court, Hosdurg who stands appointed as temporary Munsiff-Magistrate as per GO cited above, is posted as Judicial Magistrate of First Class, Thaliparamba. On relief from his present post, he will take charge as Judicial Magistrate of First Class, Thaliparamba from Shri Soman P. Mankootathil(Sl.No.9)

The Officers at Sl.No. 1, 6, 7, 9 &10 are not eligible for transfer grant and for joining time.

The Officers except at Sl.No.12, 13, 18, 26 & 30 are eligible for special allowance for extra administrative work at the rate of Rs.1,250/- per month in their new stations.

The officers at Sl.No.11 – 31 who are appointed as Temporary Munsiff-Magistrates will take charge in their respective stations on 23-09-2013. They are informed that their appointment as Temporary Munsiff-Magistrates is on condition that they shall be replaced as soon as possible by an approved candidate qualified to hold the post under the Kerala Judicial Service Rules and they shall not be regarded as probationers in the post or be entitled by reason only of such appointment to any preferential claim to future appointment. After joining duty, they will have to undergo training for a period of one month from 25-09-2013 at Kerala Judicial Academy, Ernakulam. The District Judges / Chief Judicial Magistrates concerned shall issue necessary orders relieving the officers so as to enable them to take up their appointments and to relieve them to attend training at Kerala Judicial Academy.

Officers at Sl.No.11 – 31 are eligible for Robe allowance at the rate of ₹ 6,000/- once in three years.

In the event of a relieving / relieved officer happens to be absent on the date of his taking / handing over charge, the respective officers may take / hand over charge from the officer who has been placed in full additional charge of the relieving / relieved officer on the day of absence.
