ORDER NO. B1 -- 42183 / 2013


The Officers will take charge at their respective stations on 20-05-2013. They will take the oath of allegiance to the Union of India and to the Constitution of India before the District and Sessions Judges / Chief Judicial Magistrates concerned. They will produce Medical Certificate of fitness from a Medical Officer not below the rank of a Civil Surgeon in the form prescribed in Rule 13 Part I, Kerala Service Rules before the District and Sessions Judges / Chief Judicial Magistrates on their joining duty.

The Officers are informed that they will be on probation for a period of two years on duty within a continuous period of three years subject to their passing of tests as prescribed in Rules 11 and 12 of the Kerala Judicial Service Rules, 1991.

The Officers are eligible for Robe Allowance at the rate of Rs.6,000/- once in three years. The Officers are eligible for special allowance for extra administrative work at the rate of Rs.1,250/- per month in their new stations.

Officers at Sl.No.4, 5 & 6 are eligible for three advance increments for their higher qualification(LL.M)
