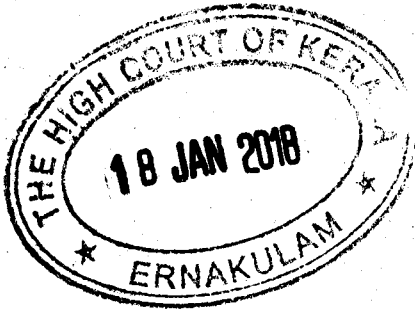

As a part of Government's policy of zero tolerance to corruption, the following instructions are issued to all Public Authorities including PSUs to prepare and disseminate the information as mandated in the proactive disclosure section of RTI Act. The concerned Department in the Government Secretariat should supervise the development in this regard in the PSUs/Autonomous Bodies/Public offices coming under their administrative control. For this the following instructions are issued.

- 2) Each department shall constitute a State level team consisting of the following:
- Head of Department
 - Senior Finance Officer
 - Administrative Officer
 - State Public Information Officer
 - Representative of the IT Cell

3) The above team will be responsible for ensuring that the concerned department which includes its offices at the State, District, Block and Grama Panchayat Level, pro-actively disclose all information as mandated under section 4(1)(b), Section 4(1)(c) and section 4(1)(d) of the RTI Act. Each Department will ensure the compliance of above direction by 20th January, 2018 and submit an Action Taken Report to GAD.

4) IMG, Thiruvananthapuram will provide training, support and facilitation to all teams constituted by the concerned Departments to ensure that the compliance is met within the time frame stipulated.

5) Each Department should prepare an action plan for developing publicly hosted IT systems that are real time and transaction based to facilitate sou-moto disclosure of information related to implementation of all aspects of the scheme.


