Judiciary – Transfer and postings of Sub Judges - Orders issued.

Read : Order No. 17/2011 dated 27.02.2012 of the Registrar, Kerala Administrative Tribunal

ORDER NO. B1 – 57 / 2012

As per the order read above, Shri K.J.Arby, Sub Judge, Tirur was appointed as Deputy Registrar(Judicial) in the Ernakulam Bench of the Kerala Administrative Tribunal. Hence the following orders are issued :

1. Shri K.K.Krishnankutty , Principal Sub Judge, Kollam is transferred and posted as Sub Judge, Tirur. He will hand over charge of his office to Shri Muralee Gopal Pandalai(SI.No.3) and take charge as Sub Judge, Tirur from Shri K.J.Arby (SI.No.2)

2. Shri K.J.Arby, Sub Judge, Tirur will hand over charge of his office to Shri K.K.Krishnankutty(SI.No.1) and proceed to take up his new appointment as Deputy Registrar(Judicial) in the Ernakulam Bench of the Kerala Administrative Tribunal.

3. Shri Muralee Gopal Pandalai, Additional Sub Judge, Kollam is posted as Principal Sub Judge, Kollam. He will take charge as Principal Sub Judge, Kollam from Shri K.K.Krishnankutty(SI.No.1) and continue to hold the full additional charge of the Additional Sub Judge, Kollam, till Shri G.Pramodkumar (SI.No.4) takes charge.

4. Shri G.Pramodkumar, Munsiff, Attingal is promoted as Sub Judge / Chief Judicial Magistrate and posted as Additional Sub Judge, Kollam. He will hand over the charge of his office to the Judicial Magistrate of First Class-I, Attingal and take charge as Additional Sub Judge, Kollam from Shri Muralee Gopal Pandalai(SI.No.3)

The Judicial Magistrate of First Class-I, Attingal will hold the full additional charge of the Munsiff, Attingal, until further orders.

5. Smt. V.G.Sreedevi, Principal Munsiff, Irinjalakuda is promoted as Sub Judge / Chief Judicial Magistrate and posted as Additional Sub Judge, Thalassery. She will hand over the charge of her office to Shri Rajan Thattil (SI.No.6) and take charge as Additional Sub Judge,Thalassery from the Principal Sub Judge, Thalassery

6. Shri Rajan Thattil, Additional Munsiff, Irinjalakuda is posted as Principal Munsiff, Irinjalakuda. He will take charge as Principal Munsiff, Irinjalakuda from Smt. V.G.Sreedevi(Sl.No.4) and continue to hold the full additional charge of the Additional Munsiff, Irinjalakuda until further orders.

The officers at Sl. Nos.1 & 3 are eligible for Special Pay for extra administrative work at the rate of Rs.750/- p.m. in their new post.

The officer at Sl. No.6 is eligible for Special Pay for extra administrative work at the rate of Rs. 500/- p.m. in his new post.

The promotion granted to the officers at Sl. No. 4 and 5 are temporary until their appointment as Sub Judge / Chief Judicial Magistrate are regularised by the High Court. The officer at Sl.No.1 is not eligible for joining time and transfer grant.
