As per the High Court Order read second the period of probation of six officers in the category of Sheristadar Sub Court /Senior Superintendent, District Court namely Smt Rajani Mohan C, Sheristadar, Sub Court, Kottayam, Smt A.G Nishadevi, Sheristadar Sub Court, Kollam, Smt Lekha.K, Sheristadar, Sub Court, Vadakara, Shri Rajeevan.K.R Sheristadar Sub Court, Karunagappally, Smt Budha P.S, Senior Superintendent District Court, Ernakulam and Shri Sethuraman.P, Sheristadar, Sub Court, Pathanamthitta had been extended for a period of one year.
