- 5. The District Judge/Chief Judicial Magistrate shall also report as to how the work of the Court will be managed during the period between the date of relief and the date of joining of a substitute/fresh hand in the event of deputation.

- 6. In the case of Confidential Assistants, the District Judge/Chief Judicial Magistrate should furnish NOC for deputation only in exceptional circumstances bearing in mind that if work of the Court is affected in any manner consequent to the deputation, the officer furnishing NOC is bound to submit explanation.
- 7. The applications should contain Bio-data, NOC and statement under Rule 144, Part I, KSRs, so as to reach this Office on or before 14/06/2018.
