Pursuant to the direction of this Honourable Court in the Judgment referred to (2) above, the draft seniority list for promotion to the category of Assistant Registrar, High Court published as per the High Court O.M. referred to (1) above, was finalised after considering all the objections filed against the said list. Since there was no change in the seniority of any of the members as published in the draft list, the draft list was finalised as such and the same was communicated as per the High Court O.M. cited (3) above.

Aggrieved by the finalisation order, a few members of the High Court Service preferred appeals under Rule 27 of the Kerala High Court Service Rules, 2007. The appeals were dismissed on merit, by the Appellate Authority and the said Order was communicated to the appellants by the High Court O.M. referred to (4) above.

The appellants, now by the representations cited (5), have requested to publish the seniority list finalised.

Accordingly, the seniority list for promotion to the category of Assistant Registrar, High Court finalised as such by the High Court O.M. cited (3) above, is published herewith.
