The draft seniority list of Senior Superintendents of Chief Judicial Magistrate Court as on 01.02.2017 is enclosed herewith. The Chief Judicial Magistrates are directed to comply with the following instructions in this regard:

1. The draft list shall be circulated among all concerned under their respective administrative control including those who are on leave, deputation and on LPR.
2. The incumbents shall be instructed to file objections, if any, regarding the draft list within 15 days from the date of receipt of this communication. They shall also be informed that objections received after the above period will not be entertained and that while filing objections, they must enclose copies of the relevant rules or orders which they rely upon and further that objections previously considered will not be entertained again.
3. The Chief Judicial Magistrates shall go through each of the objections, offer their specific remarks on each and forward to this office immediately after the expiry of the time prescribed.

4. The Chief Judicial Magistrates shall verify the draft list with the Service Registers of the incumbents concerned and shall send a report to this office if they find any omission/correction necessary in the draft list.
5. The Chief Judicial Magistrates are directed to ensure that the draft list has been shown to the Senior Superintendents under their administrative control. An acknowledgement in writing obtained from them to the effect that they have seen the draft list shall be kept in the respective Chief Judicial Magistrates Courts.
6. If any objection is not filed and no correction is necessary, the fact may be intimated to this office immediately on the expiry of the time allotted.
