8A. The post of Office Superintendent/ Office Superintendent (HG) may be placed in the revised scale corresponding to Rs.20740-36140/21240-37040. The ratio between the two posts will be 1:1.


8B. The post of Accounts Officer may be placed in the revised scale corresponding to 22360-37940.

ADDENDUM

1. The post of Confidential Assistant Grade II may be placed in the revised scale corresponding to 13900-24040.
2. The post of Private Secretary to Judge may be placed in the revised scale corresponding to 24040-38840.
3. The post of Private Secretary (HG) to Judge may be placed in the revised scale corresponding to 36140-49740.
4. The ratio between Private Secretary/Private Secretary (HG) is revised to 3:1 (25 %) from the existing 1:1 (50%)
5. The posts of Head Chauffer may be increased to 3 from the existing 1, as in Tourism Department in the revised scale corresponding to 14620-25250.
6. In view of the very arduous work even on holidays, the Assistant Engineer (Electrical) may be allowed a Special Allowance @ Rs.1500/- per month.
7. In view of the night duty work required of watchmen they may be allowed a compensatory allowance of Rs. 500 per month as long they continue in that post.
