Officers except SI.Nos.35 are eligible for Special pay for extra administrative work at the rate of ₹ 1,250 /- in their new posts.

Officers are eligible for Robe Allowance at the rate of ₹ 6,000/- once in three years.

The officers will take charge at their respective stations on 11-07-2016. They will take oath of allegiance to the Union of India and to the Constitution of India before the District and Sessions Judges / Chief Judicial Magistrates concerned. They will produce Medical Certificates of fitness from a Medical Officer not below the rank of a Civil Surgeon in the form prescribed in Rule 13, Part I, Kerala Service Rules before the District and Sessions Judges / Chief Judicial Magistrates on their joining duty. They are informed that they will be on probation for a period of two years on duty within a continuous period of three years subject to their passing of tests prescribed in Rules 11 and 12 of the Kerala Judicial Service Rules, 1991.

The District Judge / Chief Judicial Magistrate are directed to make necessary charge arrangements and to ensure that at least two days sitting in a week is conducted in the vacant courts. The copy of the charge arrangements may be communicated to the High Court.

The officers are informed that the above appointments shall be subject to the result of WP(C)No. 15424 / 2013, WP(C) No. 15769 / 2013, WP(C) No. 7316 / 2015, WP(C) No. 8511 / 2015 & WA No. 316 / 2015 pending before the High Court of Kerala.
