ORDER NO. B1- 59 / 2014

As per G.O read as first paper above, the Government have sanctioned 27 Temporary Judicial First Class Magistrate's Courts utilizing the funds allotted by the 13th Finance Commission. The High Court has decided to start functioning of two courts at Thiruvananthapuram and one court each at Kothamangalam and Kadakkal with effect from 23-08-2014 and the Courts at Kuruppumpady, Mattanchery and Kalady w.e.f 26.08.2014, 27.08.2014 and 30.08.2014 respectively. As per G.O read as second paper above the Government of Kerala, based on the recommendation of the High Court, have appointed 27 Temporary Munsiff- Magistrates under Rule 9 sub rule (1) of the Kerala Judicial services Rules 1991. In the circumstances, following orders are issued :
