


Quotation offering the maximum discount will ordinarily be accepted. However, the Registrar General reserves the right to reject all or any one of the quotations without assigning any reason.

The rates quoted should be for supply of **parts/ issues** (not Bound Volumes) of Foreign Journals/ Periodicals at the office of Library, High Court of Kerala .The rates of Journals/ Periodicals available in **online mode** has to be quoted separately. The prices quoted must be inclusive of taxes, rate, fees, and duties. Where advance payment is insisted on, an agreement has to be executed on the receipt of confirmed orders. The Journals/ Periodicals are to be supplied as and when published. In case of any deviation from the agreement, the High Court reserves the right to cancel the contract without further notice or recover the liquidated damages, if any.

The last date & time for receipt of quotation is **21.03.2018 at 2.30 PM**. Any quotation received after the prescribed time on due date is liable to be rejected. The quotations will be opened by Registrar General/ Registrar General in-charge at **3.00 PM** on **21.03.2018** in the presence of such of the tenderers or of the authorized representatives who may be present at that time.
