ORDER NO. C6 - 21021/2016 (II)

As per the High Court Proceedings read as first paper above, promotions against the vacancies that arose till 01/12/15 have been granted to the Confidential Assistants in the Criminal Wing of Subordinate Judiciary based on the seniority list as on 01/01/2014.

According to the High Court Proceedings read as second paper above, Smt. Dilna P.C. is granted notional promotion to the post of Confidential Assistant Gr.I w.e.f 01/10/2015 and she is accommodated in the next arising regular vacancy on 01/03/2016 (vice Smt. Shaيدا M.M., Sl.No.66). The seniority of Smt. Dilna P.C. stands restored to that extent in the final seniority list as on 01/03/2016.

The ratio among Confidential Assistant, Selection Grade, Senior Grade, Grade I and Grade II categories is 1:1:1:1. The total sanctioned strength of Confidential Assistants in the Criminal Judicial Department as on 01/03/2016 (date of seniority list) is 128.

Six vacancies that arose in Selection Grade category of Confidential Assistant on account of retirements and the consequential vacancies in the lower grades are to be filled up.

The seniority list of Confidential Assistants in the Criminal Wing of the Subordinate Judiciary as on 01/03/2016 has been finalised as per the proceedings read as third paper above.

Under these circumstances, the following promotions are granted to the Confidential Assistants of Criminal Wing of Subordinate Judiciary based on the finalised seniority list as on 01/03/2016.
