

The Chief Judicial Magistrates shall circulate the same among Confidential Assistants working under their administrative control including those who have already retired from service but are included in this list.

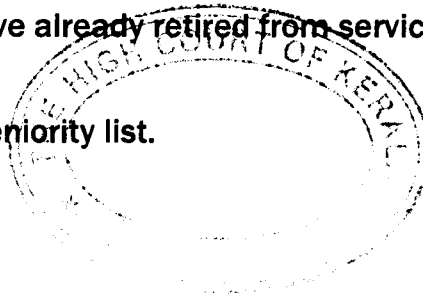
