The period of deputation including the period of deputation (Including Short Term Contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not exceed 3 (Three) years. The maximum age limit for deputationist shall not be exceeding the age of 56 years on the last date of receipt of applications.
