Judiciary – Filling up the vacancies of Munsiff-Magistrates in the Kerala Judicial Service- posting of temporary Munsiff-Magistrates appointed as per GO(MS) No. 257/2012/Home dated 03-10-2012/Consequential transfers and postings of Munsiff-Magistrates-Orders issued

ORDER NO. B1 -57/2012

As part of filling up of the existing vacancies of Munsiff- Magistrates in the State Subordinate Judiciary the following orders are issued :

1. Sri. Tomy Varghese, Judicial Magistrate of First Class, Pala who is also holding the additional charge of the Munsiff, Pala is posted as Munsiff, Pala. He will handover charge of his office to Sri. Thomas Varughese(SI No 19) and take charge as Munsiff, Pala.

2. Smt P.N. Seetha, Judicial Magistrate of First Class, Irinjalakuda is transferred and posted as Principal Munsiff, Irinjalakuda. She will handover charge of her office to Sri Bijumon A.S. (SI No16) and take Charge as Principal Munsiff, Irinjalakuda from Sri.Rajan Thattil (SI.No.3).

3. Sri.Rajan Thattil, Principal Munsiff, Irinjalakkuda who is also holding the additional charge of the Additional Munsiff, Irinjalakuda is posted as Additional Munsiff, Irinjalakuda . He will handover charge of his office to Smt P.N. Seetha (SI No.2) and take Charge as Additional Munsiff, Irinjalakuda.

4. Sri.Rajiv Jayaraj.Judicial Magistrate of First Class, Kunnamangalam is transferred and posted as Prl. Munsiff, Kozhikode-I. He will handover charge of his office to Sri N.Prasannan(SI.No 23)and take charge as Prl. Munsiff, Kozhikode-I from Smt. Vinitha. V (SI.No 10).

5. Sri.A.Ijas, Judicial Magistrate of First Class,-III, Thiruvananthapuram is posted as Addl.Munsiff-III, Thiruvananthapuram. He will handover charge of his office to Sri. T.A Ramachandran(SI No.18) and take charge as Addl. Munsiff-III,Thiruvananthapuram from the Principal Munsiff, Thiruvananthapuram.

6. Sri. Sathishkumar A.G, Judicial Magistrate of First Class, Kodungallur who is also holding the additional charge of Munsiff, Kodungallur is posted as Munsiff, Kodungallur. He will handover charge of his office to Sri. Thariyachan M.T (SI No.22) and take charge as Munsiff, Kodungallur.

7. Smt Vani. K.M , Judicial Magistrate of First Class-III,Kottayam is posted as Addl .Munsiff, Kottayam. She will handover charge of her office to Sri Rajeev V (SI No.15) and take charge as Addl .Munsiff, Kottayam from the Principal Munsiff, Kottayam.

8. Sri Sreeraj S, Judicial Magistrate of First Class, Thaliparamba is transferred and posted as Additional Munsiff , Kannur. He will handover charge of his office to Sri George Joseph (SI. No. 32) and take charge as Additional Munsiff Kannur from the Principal Munsiff, Kannur.

9. Smt. Manju V, Judicial Magistrate of First Class-II, Neyyattinkara is posted as Additional Munsiff-II, Neyyattinkara. She will hand over charge of her office to Sri Jacob C John(SI No 27) and take charge as Additional Munsiff-II, Neyyattinkara from the Additional Munsiff-I, Neyyattinkara.

10. Smt. Vinitha V , Principal Munsiff, Kozhikode-I who is also holding the additional charge of Additional Munsiff, Kozhikode-I is posted as Additional Munsiff, Kozhikode-I . She will handover charge of her office to Sri.Rajiv Jayaraj(SI.No. 4) and take charge as Additional Munsiff, Kozhikode-I.

11. Sri.Sanjaikumar V.K., Judicial Magistrate of First Class, Koyilandi is posted as Munsiff, Koyilandi. He will hand over charge of his office to Sri. Avaneendranath P (SI No 26) and take charge as Munsiff, Koyilandi from the Special Judicial Magistrate of First Class (Marad Cases), Kozhikode.

As per the Government Order read first, the Government of Kerala based on the recommendation of the High Court are pleased to appoint 21 officers from the panel furnished by the High Court,as temporary Munsiff-Magistrates under Rule 9 sub rule (1) of the Kerala Judicial Services Rules 1991. The 21 appointees are posted in the vacancies of Munsiff- Magistrates in the State Subordinate Judiciary as detailed below.

12. Sri. Eldos Mathew, Assistant Librarian, High Court of Kerala / temporary Munsiff-Magistrate is posted as the Judicial Magistrate of First Class-II (Mobile Court) Kottayam. On his relief from the present post, he will take charge as the Judicial Magistrate of First Class-II (Mobile Court), Kottayam from the Judicial Magistrate of First Class-I, Kottayam.

13. Sri. S Sajeev, UD Clerk(H.G), Munsiff's Court, Ranny (presently working as Secretary,TLSC, Ranni) / temporary Munsiff-Magistrate is posted as the Judicial Magistrate of First Class Idukki. On his relief from the present post, he will take charge as the Judicial Magistrate of First Class Idukki from the Munsiff ,Idukki.

14. Sri.Satheesan M, Junior Superintendent, District Court Thiruvananthapuram / temporary Munsiff-Magistrate is posted as the Judicial Magistrate of First Class-II (Forest Offences) Punalur . On his relief from tthe present post, he will take charge as the Judicial Magistrate of First Class-II (Forest Offences) Punalur from the Judicial Magistrate of First Class-III, Punalur.

15. Sri. Rajeev V, Legal Assistant (Sr.Gr.), Law Department, Thiruvananthapuram/ temporary Munsiff-Magistrate is posted as the Judicial Magistrate of First Class-III Kottayam . On his relief from the present post, he will take charge as the Judicial Magistrate of First Class-III Kottayam from Smt Vani.K.M (Sl.No. 7)

16. Sri.Bijumon A.S., Amin, District Court, Thiruvananthapuram/ temporary

Munsiff-Magistrate is posted as the Judicial Magistrate of First Class Irinjalakuda . On his relief from the present post, he will take charge as the Judicial Magistrate of First Class Irinjalakuda from Smt. P.N. Seetha(SI No.2).

17. Sri.Donald Sequera, U.D Clerk, JFCM Court, Chalakudy / temporary Munsiff-Magistrate is posted as the Judicial Magistrate of First Class-II (Forest Offences) Manjeri. On his relief from the present post, he will take charge as the Judicial Magistrate of First Class-II (Forest Offences) Manjeri from the Judicial Magistrate of First Class-I Manjeri.

T.A Ramachandran, Bench Clerk Gr.I, MACT, Alappuzha(On deputation as Secretary Ambalapuzha Taluk Legal Services Commitee, Alapuzha / temporary Munsiff-Magistrate is posted as the Judicial Magistrate of First Class-III Thiruvananthapuram. On his relief from the present post, he will take charge as the Judicial Magistrate of First Class-III Thiruvananthapuram from Sri A. Ijas (SI No.5).

19. Sri. Thomas Varughese, Head Clerk. CJM Court, Kalpetta (Section Officer, DLSA, Pathanamthitta on deputation) / temporary Munsiff-Magistrate is posted as the Judicial Magistrate of First Class Pala. On his relief from the present post, he will take charge as the Judicial Magistrate of First Class, Pala from Sri Tomy Varghese(SI No.1)

20 Sri. Remesh .N, Junior Superintendent. Munsiff's Court, Kochi / temporary Munsiff-Magistrate is posted as the Judicial Magistrate of First Class-II (Mobile Court), Kozhikode. On his relief from the present post, he will take charge as the Judicial Magistrate of First Class-II(Mobile Court), Kozhikode from the Judicial Magistrate of First Class-I, Kozhikode .

21. Sri. K.K. Ashok, Section Officer/ Court Officer, High Court of Kerala / temporary Munsiff-Magistrate is posted as the Judicial Magistrate of First Class-II Nedumangad. On his relief from the present post, he will take charge as the Judicial Magistrate of First Class-II Nedumangad from the Judicial Magistrate of First Class-III(Forest Offences), Nedumangad.

22. Sri. Thariyachan M.T, Bench Clerk(Gr.I), Addl District& Sessions Court (Adhoc-1), Ernakulam/ temporary Munsiff-Magistrate is posted as the Judicial

Magistrate of First Class Kodungallur. On his relief from the present post, he will take charge as the Judicial Magistrate of First Class Kodungallur from Sri. Sathishkumar A.G(SI.No. 6).

23. Sri. N.Prasannan, Asst. Public Prosecutor Gr.II, JFCM Court-II, Ernakulam (presently Asst. Public Prosecutor Gr.II, JFCM Court-I, Aluva)/ temporary Munsiff-Magistrate is posted as the Judicial Magistrate of First Class Kunnamangalam. On his relief from the present post, he will take charge the Judicial Magistrate of First Class Kunnamangalam. from Sri Rajiv Jayaraj (SI. No.4).

24. Sri. K, Shaji, Junior Superintendent, Sub Court, Cherthala / temporary Munsiff-Magistrate is posted as the Judicial Magistrate of First Class Peermade. On his relief from the present post, he will take charge as the Judicial Magistrate of First Class Peermade from the Munsiff- Magistrate, Peermade.

25. Sri. Soman P Mamkuttathil, Assistant Professor in Law, Law College, Ernakulam / temporary Munsiff-Magistrate is posted as the Judicial Magistrate of First Class-III (Mobile Court), Kannur. On his relief from the present post, he will take charge as the Judicial Magistrate of First Class-III (Mobile Court), Kannur from the Judicial Magistrate of First Class-I , Kannur.

The officers at Sl. Nos 12 to 32 who are appointed as Temporary Munsiff-Magistrates will take charge in their respective stations on 29.10.2012 F.N. They are informed that their appointment as Temporary Munsiff- Magistrates is on condition that they shall be replaced as soon as possible by an approved candidate qualified to hold the post under the Kerala Judicial Service Rules and they shall not be regarded as probationers in the post or be entitled by reason only of such appointment to any preferential claim to future appointment.. After joining duty, they will have to undergo training for a period of one month as and when call letters are received from the Director, Kerala Judicial Academy. The concerned District Judges and Chief Judicial Magistrates shall issue necessary orders relieving the officers so as to enable them to take up their appointments.

The Officers at Sl.Nos. 1, 2, 4, 6, 11 and 12 to 32 are eligible for Special Pay for extra administrative work @ Rs.500/- per month in their new stations. The Officers at Sl.Nos. 12 to 32 are also eligible for Robe allowance @ Rs. 6000/- in three years.


The Officer at Sl.No.4 is eligible for joining time and transfer T.A.
