Judiciary – Posting of newly recruited Munsiff-Magistrates - Orders issued.

They will produce Medical Certificate of fitness from a Medical Officer not below the rank of a Civil Surgeon in the form prescribed in Rule 13 Part I, Kerala Service Rules before the District and Sessions Judges / Chief Judicial Magistrates on their joining duty.

The Officers are informed that they will be on probation for a period of two years on duty within a continuous period of three years subject to their passing of tests as prescribed in Rules 11 and 12 of the Kerala Judicial Service Rules,1991.

The Officers are eligible for Robe Allowance at the rate of Rs.6,000/- once in three years. The Officers at Sl.No. 1, 3, 5, 6, 8, 9, 11 to 16 & 18 are eligible for special pay for extra administrative work at the rate of Rs.500/- per month in their new stations.
