

Lissamma Joseph Murickan, Assistant Registrar, High Court in the scale of pay of Rs.45800-89000 is promoted as Assistant Registrar (H.G), High Court in the scale of pay of Rs.68700-110400 w.e.f. 16.7.2017 F.N. on temporary basis under the Rule read (2) above vice Sri.V.Sudhakran, Assistant Registrar(H.G) promoted as Deputy Registrar on temporary basis per the High Court proceedings read (3) above. As there is no change of duty involved, Smt. Lissamma Joseph Murickan need not take charge in the newly promoted post/ hand over charge of the post.

Smt.Jeeja Bhaskar, Section Officer(H.G)/Court Officer(H.G), High Court in the scale of pay of Rs.40500-85000 is promoted as Assistant Registrar, High Court in the scale of pay of Rs.45800-89000 under the Rule read (1) above, on temporary basis,under the Rule read (2) above vice Sri.K.S.Rajan., Assistant Registrar proceeded on leave preparatory to retirement as per the High Court proceedings read (3) above. 4.Smt.Preetha J.Nair , Section Officer (H.G)/Court Officer (H.G), High Court in the scale of pay of Rs.40500-85000 is appointed as Filing Scrutiny Officer, High Court in the scale of pay of Rs.42500-87000 with compensatory allowance at the rate of Rs.1000/- per month on temporary basis under the Rule read (2) above vice Smt.Anandavally K., Filing Scrutiny officer promoted as Assistant Registrar on temporary basis as above. Smt.Preetha J.Nair will hand over the charge of Section Officer (H.G)/ Court Officer (H.G) to Sri. V.S. Ajith Kumar, Section Officer (H.G)/ Court Officer (H.G), High Court and will take charge as Filing Scrutiny Officer from Smt.Anandavally K.(Sl.No.3.) forthwith.
