Sri.P.S.Sreejith will hand over the charge of Filing Scrutiny Officer to V.S.Ajith Kumar, Filing Scrutiny Officer and will take charge as Assistant Registrar from Sri.K.S.Radhakrishnan (Sl.No.1), forthwith.

Sri.Santhoshkumar (PEN 602639), Filing Scrutiny Officer, High Court in the scale of pay of ₹42500-87000 is promoted as Assistant Registrar in the scale of pay of ₹45800-89000 on temporary basis under the Rule read (1) above, vice Smt.Indulekha V. (Sl.No.4) promoted as Assistant Registrar(H.G) as above. Sri.Santhoshkumar will hand over the charge of Filing Scrutiny Officer to V.J.Ranjit, Filing Scrutiny Officer and will take charge as Assistant Registrar from Smt.Brinda Mary (Sl.No.2), forthwith.

The above promotions will be subject to the decision in WP(C).No.23797/2019, pending before the Honourable High Court.
