Judiciary –Promotions of Munsiff-Magistrates as Sub Judges / Chief Judicial Magistrates –
Consequential Transfers and Postings – Orders issued

ORDER NO. B1-43277/2016

Inorder to fill up the vacancies of Sub Judges/Chief Judicial Magistrates in the Subordinate Judiciary, the High Court has decided to grant promotion to the Munsiff-Magistrates at Sl.No.1 to 13 as Subordinate Judges/Chief Judicial Magistrates. Accordingly, the officers at Sl. No. 1 to 13 in Column II are promoted as Subordinate Judges/Chief Judicial Magistrates and posted as shown in column No. III. Consequent thereto, the officers at Sl.No's. 14-17 are posted as indicated against their names in column No.III. The posting of the officers at Sl.No's.16 and 17 will be subject to the receipt of the Government Orders in that regard. The officers at Sl.No's.7 and 10 will take charge in their promoted posts only on the relief of the officers at Sl.No's.16 and 17 from their present posts.

The District Judges/Chief Judicial Magistrates concerned will make necessary charge arrangements in respect of the officers within their jurisdiction. The charge arrangements so made shall be forwarded to the High Court for ratification.
