ORDER NO. C3-32879/2015

The vacancies in the post of Junior Superintendent (HG) that arose till 30/01/2017 were filled up as per High Court Proceedings read as 2nd paper above. The vacancies that arose thereafter due to the promotion of Higher Grade Junior Superintendents as Sub Court Sheristadar/Senior Superintendent and due to increment are remaining to be filled up. Smt.D.Geetha, i.e, Sl.No.164, of the Seniority List read as 1st above, was the last candidate promoted.

Sri.N.Chitrarajan, Munsiff's Court, Neyyattinkara (Sl.No. 86) was not granted promotion as disciplinary proceedings was pending against him (though was due for promotion as Junior Superintendent (Higher Grade) w.e.f. 01/06/2015). The disciplinary proceedings against Sri.Chitrarajan has been finalised as per Proceedings read as 5th paper above. The High Court has considered the matter of granting ratio based higher grade to Sri.N.Chitrarajan in detail.

On finalisation of the disciplinary proceedings against Sri.N.Chitrarajan, the punishment imposed was that of withholding of one increment with cumulative effect from 01/03/2017. The ratio based higher grade are only benefits allowed on the basis of pay revision orders. They are not regular promotion posts. Granting of such higher grades does not involve a selection process. The criteria for such promotion is

only seniority in accordance with Rule 27 (a), Part II, KS&SSRs. Taking all the above aspects into consideration the High court has decided that Sri.N.Chitrarajan be granted notional promotion to the non selection post of Junior Superintendent (Higher Grade) w.e.f. 01/06/2015 and he be accomodated in the vacancy that arose on 01/03/2017, i.e., the date of finalisation of the disciplinary proceedings against him.

In the circumstances, the following promotions are granted.
