Sub:Draft Seniority list of Junior Superintendents(Civil wing) including Head Clerks of Motor Accidents Claims Tribunal and Head Clerks of Munsiff- Magistrates' Courts(Civil wing) of the Subordinate Judiciary as on 01/03/2018 -Reg.

The draft seniority list of Junior Superintendents(Civil wing) including Head Clerks of Motor Accidents Claims Tribunal and Head Clerks of Munsiff- Magistrates' Courts(Civil wing) of the Subordinate Judiciary as on 01/03/2018 is enclosed herewith.The District Judges are directed to follow the instructions hereinunder:

1. The draft seniority list shall be circulated among all the Junior Superintendents /Head Clerks of Motor Accidents Claims Tribunals/Head Clerks of Munsiff-Magistrates' Courts working in their respective districts including those who are on leave, deputation and those retired after the above date and acknowledgment from them to the effect that they have seen the draft list shall be kept in the respective district.
2. The draft list shall also be affixed in the notice board of the office.It shall also be brought to the notice of the staff members that the draft list is available in the website of the High Court also.
3. The incumbents shall be instructed to file objections, if any, regarding the draft list within 15 days from the date of receipt of this communication. They shall also be informed that objections received after the above period will not be entertained and that while filing objection, they must enclose the copies of the relevant rules or orders which they rely upon supporting the claim. Objections previously considered will not be entertained again.

4. The District Judges shall go through the petitions, and forward the same to this office immediately after the expiry of the time prescribed, along with their specific remark on each of the petition.

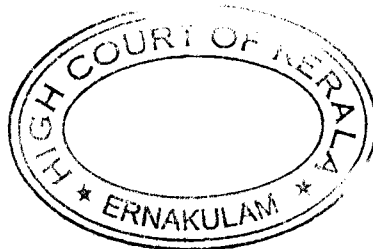
5. The draft list shall be verified with the service registers of the incumbents concerned and a report shall be sent to this office as to whether any omission/ correction is required in the list.

6. If objection is not filed and no correction is necessary, the fact may be intimated to this office.

7. Special attention shall be given to entries in Column.2 and it shall be reported whether the original designation of the employee concerned is Junior Superintendent/Head Clerk, Motor Accidents Claims Tribunal/Head Clerk, Munsiff-Magistrate Court, with the station of the officer concerned.

In the case of those appointed as Head Clerk, Motor Accidents Claims Tribunal/ Head Clerk, Munsiff- Magistrates' Court, a copy of the order of appointment shall be furnished. The scale of pay allowed to such appointees shall also be specified.

8. The District Judges concerned shall furnish the details of appointment to the post of Junior Superintendent and the reversion from the post of Junior Superintendent in respect of Sl Nos.67,68,81,107,108,118,154,222 & 235 along with related orders and report whether their initial appointment as Junior Superintendent had been against substantive vacancies or whether it had been temporary under Rule 31(a)(1) of KS&SSRs.
