The draft seniority list of Confidential Assistants in the Criminal Wing of Subordinate Judiciary as on 01/03/2018 is enclosed herewith.

The Chief Judicial Magistrates are directed to comply with the following instructions in this regard:

1. The draft list shall be circulated among all Confidential Assistants working in their respective districts including those who are on leave, deputation and on other duty.
2. The incumbents shall be instructed to file objections, if any, regarding the draft list within 30 days from the date of receipt of this communication. They shall also be informed that objections received after the above period will not be entertained and that while filing objections, they must enclose copies of the relevant rules or orders which they rely upon. Objections previously considered will not be entertained again.
3. The Chief Judicial Magistrates shall go through each of the objections and forward the same to the Registry along with his specific remarks, immediately after the expiry of the time prescribed. If no objection is received, the same shall be intimated to the High Court.
4. The Chief Judicial Magistrates shall verify the draft list with the Service Registers of the incumbents concerned and shall send a report to this office if they find any omission to be supplied/ correction to be effected in the draft list.

5. The Chief Judicial Magistrates are directed to ensure that the draft list has been shown to each and every Confidential Assistant working under their administrative control. An acknowledgment in writing obtained from them to the effect that they have seen the draft list shall be kept in the respective Court.
6. The Chief Judicial Magistrates are further directed to take steps to declare the probation of the eligible candidates in C.A Gr. II and report the details therein. They are also directed to report the details of Confidential Assistants in all grades those who are on LWA under Appendix XII A, B or C and the details of disciplinary proceedings finalised/pending against them, if any.
