
The Government as per the Government Orders read as 1st and 3rd paper above have revised the existing upper monetary limit to various categories of officers for sanctioning Temporary Advance(TA)/Non-Refundable Withdrawal(NRW) from the General Provident Fund (GPF) and the Kerala Part Time Contingent Employees Provident Fund (KPTCEPF).

The Honourable the Chief Justice is pleased to order that in modification of the orders issued in the High Court proceedings read 4th paper above, the power to sanction Temporary Advance(TA) / Non-Refundable Withdrawal(NRW), to the members of the High Court service from the General Provident Fund (GPF), and to the Part Time Contingent Employees of the High Court from the Kerala Part Time Contingent Employees Provident Fund (KPTCEPF), shall be exercised by the following sanctioning authorities subject to the upper monetary limit as specified below:

5	Assistant Registrar	Non-Gazetted and Last Grade Employees Part Time Contingent Employees	₹3,90,000/- ₹75,000/-
