The vacancies in the categories of Joint Registrar, Deputy Registrar, Assistant Registrar (H.G) and Assistant Registrar in the High Court are filled up on temporary basis under the Rule read (1) above as follows:

Smt.V.Prabha, Deputy Registrar, High Court in the scale of pay of Rs.77400-115200 is promoted as Joint Registrar, High Court in the scale of pay of Rs.85000-117600 on temporary basis vice Sri.Sabu K.Varghese, Joint Registrar, promoted and appointed as Additional Registrar(General Administration), High Court as per the High Court proceedings read (2) above. Anilkumar, Assistant Registrar, High Court in the scale of pay of Rs.45800-89000 is promoted as Assistant Registrar (H.G), High Court in the scale of pay of Rs.68700-110400 on temporary basis vice Sri.Valentine Gilson Fernandez, Assistant Registrar(H.G) retired from service on superannuation as per the High Court proceedings read (4) above.

As there is no change of duty involved, Sri.P. Anilkumar need not take charge in the newly promoted post/ hand over charge of the post.

Smt.N.Sudha, Assistant Registrar, High Court (now working as Court Officer to the Chief Justice) in the scale of pay of Rs.45800-89000 is promoted as Assistant Registrar (H.G), High Court in the scale of pay of Rs.68700-110400 on temporary basis vice Sri.P.Sreedhar, Assistant Registrar(H.G) promoted as Deputy Registrar, High Court on temporary basis as above. Smt. N.Sudha will hand over the charge of Court Officer to the Chief Justice to Sri.Ramesh Dev S., Section officer(H.G)/Court Officer(H.G) and will take charge as Assistant Registrar(H.G) from Sri.P.Sreedhar(SI.No.2) forthwith.



Vijayakumary P., Assistant Registrar, High Court in the scale of pay of Rs.45800-89000 is promoted as Assistant Registrar (H.G), High Court in the scale of pay of Rs.68700-110400 on temporary basis vice Sri.M.Sebastian Joseph, Assistant Registrar(H.G) promoted as Deputy Registrar on temporary basis as above. As there is no change of duty involved, Smt. Vijayakumary P. need not take charge in the newly promoted post/ hand over charge of the post.

Sri.Alfred R., Filing Scrutiny Officer, High Court in the scale of pay of Rs.42500-87000 is promoted as Assistant Registrar, High Court in the scale of pay of Rs.45800-89000 on temporary basis, vice Sri.P.Anilkumar, Assistant Registrar promoted as Assistant Registrar (H.G) on temporary basis as above. Sri.Alfred R. will hand over the charge of Filing Scrutiny Officer to Sri.N.V.Paul, Filing Scrutiny Officer and will take charge as Assistant Registrar from Sri.P.Jayakumar, Assistant Registrar, High Court, forthwith.

8.Sri.D.Narayanan Moothath, Section Officer(H.G)/Court Officer(H.G) now working as Finance Officer, High Court in the scale of pay of Rs.77400-115200, is notionally promoted as Assistant Registrar, High Court in the scale of pay of Rs.45800-89000 on temporary basis, vice Smt.Vijayakumary P., Assistant Registrar promoted as Assistant Registrar (H.G) on temporary basis as above. Sri.D.Narayanan Moothath is allowed to continue as Finance Officer, High Court on higher scale of pay.

9.Sri.V.S.Jyothilal Prasad, Filing Scrutiny Officer, High Court in the scale of pay of Rs.42500-87000 is promoted as Assistant Registrar, High Court in the scale of pay of Rs.45800-89000 on temporary basis, vice Sri.D.Narayanan Moothath(SI.No.8) allowed to continue as Finance Officer, High Court as above. Sri.V.S.Jyothilal Prasad will hand over the charge of Filing Scrutiny Officer to Sri.M.Aravindakshan, Filing Scrutiny Officer, High Court and will take charge as Assistant Registrar from Sri.M.Sebastian Joseph (SI.No.3.) forthwith.
