High Court establishment- filling up of the vacancy of Registrar (Finance) and the consequent vacancy of Registrar (Judicial), High Court- orders issued.

1. Sri.Mathews K.Nelluvely (PEN 601651), Registrar (Judicial), High Court on the scale of pay of Rs.89000-120000 with compensatory allowance of Rs.1000/- per month, who is holding the full additional charge of Registrar (Finance) is appointed as Registrar (Finance), High Court on the same scale of pay with compensatory allowance at the same rate, forthwith.
