High Court establishment- filling up of vacancies in the category of Assistant Registrar (H.G), Assistant Registrar and Filing Scrutiny Officer, High Court- orders issued.

Order No.A5- 44403/2018(2)

As per the High Court proceedings read (1) above, the cadre strength in the category of Assistant Registrar has been re-fixed. Consequently, two vacancies have arisen in the category of Assistant Registrar (H.G.), w.e.f. 1.7.2019. As there is no change of duty involved in the case of promotion to the post of Assistant Registrar (H.G), promotions can be effected from the date of occurrence of vacancies, and the promotees need not take charge in the promoted post/hand over charge of the post.

In the circumstances, the existing vacancies including those consequent on re-fixation are filled up, as follows:

Sri.C.Salim, (PEN124233) Assistant Registrar, High Court in the scale of pay of ₹45800-89000 is promoted as Assistant Registrar(H.G) in the scale of pay of ₹68700-110400, w.e.f. 4.7.2019 F.N., on temporary basis under the Rule read (2) above, vice Sri.Sureshkumar D., Assistant Registrar(H.G) promoted as Deputy Registrar on temporary basis, as per the High Court proceedings read (3) above.

Sri.John T.Sam (PEN 599565), Filing Scrutiny Officer, High Court in the scale of pay of ₹42500-87000 is promoted as Assistant Registrar in the scale of pay of ₹45800-89000 on temporary basis under the Rule read (2) above, vice Smt.M.J.Selvi, (Sl.No.3) promoted as Assistant Registrar(H.G) as above. Sri.John T.Sam will hand over the charge of Filing Scrutiny Officer to Smt.Sreeja Lakshmi T.N.,(Sl.No.7) and will take charge as Assistant Registrar from Smt.A.B.Sheelakumari, Assistant Registrar (H.G.), forthwith.

6. Smt.Joisy Paul (PEN123756), Filing Scrutiny Officer, High Court in the scale of pay of ₹42500-87000 is promoted as Assistant Registrar in the scale of pay of ₹45800-89000 on temporary basis under the Rule read (2) above, vice Sri.C.Salim, (Sl.No.4) promoted as Assistant Registrar(H.G) as above. Smt.Joisy Paul will hand over the charge of Filing Scrutiny Officer to Smt.Bindumol P.S., (Sl.No.8) and will take charge as Assistant Registrar from Sri.C.G.Suresh Kumar, Assistant Registrar, forthwith.

7. Smt.Sreeja Lakshmi T.N.,(PEN123702), Section Officer (H.G)/Court Officer (H.G), High Court in the scale of pay of ₹40500-85000 is appointed by transfer as Filing Scrutiny Officer on temporary basis under the Rule read (2) above, in the scale of pay of ₹42500-87000 with a compensatory allowance of Rs.1000/- per month, vice Sri.John T.Sam, (Sl.No.5) promoted as Assistant Registrar as above. Smt.Sreeja Lakshmi T.N., will hand over the charge of Section Officer (H.G)/Court Officer(H.G) to Smt.Rajani K.S., Section Officer(H.G)/Court Officer(H.G), High Court and will take charge as Filing Scrutiny Officer from Sri.John T.Sam (Sl.No.5) forthwith.

8. Smt.Bindumol P.S.,(PEN123707), Section Officer (H.G)/Court Officer (H.G), High Court in the scale of pay of ₹40500-85000 is appointed by transfer as Filing Scrutiny Officer on temporary basis under the Rule read (2) above, in the scale of pay of ₹42500-87000 with a compensatory allowance of Rs.1000/- per month, vice Smt.Joisy Paul, (Sl.No.6) promoted as Assistant Registrar as above. Smt.Bindumol P.S, will hand over the charge of Section Officer(H.G)/Court Officer(H.G) to Sri.Dinesh Kumar K.S., Section Officer/Court Officer, High Court and will take charge as Filing Scrutiny Officer from Smt.Joisy Paul (Sl.No.6) forthwith.
