In the light of interim order of the Honourable Court read (1) above, the Honourable then Chief Justice has inter alia ordered that filling up of further vacancies that are likely to arise in the category of Private Secretary (H.G.) to Judge be deferred for the time being.

In the circumstance, the following orders are issued:

(1) Smt. Ananthavalli R. (PEN 373629), Personal Assistant (Selection Grade) to Judge, High Court in the scale of pay of Rs.39500-83000 with compensatory allowance of Rs.700/- per month is promoted as Private Secretary to Judge, High Court in the scale of pay of Rs.45800-89000 with compensatory allowance at the same rate on temporary basis under the rule read (3) above against the vacancy left unfilled in the category of Private Secretary(H.G.) to Judge, invoking Article 72 of Kerala Financial Code Vol.I. vice Smt.K.Laila, Private Secretary (H.G.) to Judge proceeded on leave preparatory to retirement as per High Court proceedings read (4) above. Smt. Ananthavalli R. will hand over the charge of Personal Assistant (Selection Grade) to Judge, High Court to Smt. Deepa S. Vijayan, (Sl.No.2), and will take charge as Private Secretary to Judge, High Court from Smt.Lalitha S., Private Secretary(H.G.) to Judge, High Court forthwith.

(2) Smt. Deepa S. Vijayan (PEN 323216), Personal Assistant (Grade I) to Judge, High Court in the scale of pay of Rs.32300-68700 with compensatory allowance of Rs.700/- per month is promoted as Personal Assistant (Selection Grade) to Judge, High Court in the scale of pay of Rs. 39500-83000 with compensatory allowance at the same rate on temporary basis under the rule read (3) above, vice Smt. Ananthavalli R., promoted as Private Secretary to Judge as above. Smt.Deepa S. Vijayan, will take charge as Personal Assistant (Selection Grade) to Judge, High Court from Smt. Ananthavalli R. (Sl.No.1).
