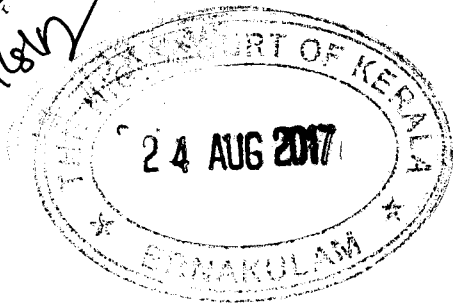

Order No. A2-428/2017

The Honourable the Chief Justice after considering the pending allegations and adverse remarks in the Annual Confidential Reports of Sri. Shameer Babu S. Y., Assistant, High Court had ordered that he shall not be considered for promotion to the post of Senior Grade Assistant, High Court and accordingly as per the High Court proceedings read (1) above, he had been superseded for promotion to the post of Senior Grade Assistant, High Court.

Considering the explanation submitted by Sri. Shameer Babu S. Y. with regard to the allegations raised against him, the Honourable the Chief Justice has taken a lenient view and ordered that he shall be promoted as Senior Grade Assistant, High Court provisionally, subject to the decision taken on the report obtained after the expiry of observation period of Sri. Shameer Babu S. Y.

Accordingly, Sri. Shameer Babu S. Y., Assistant, High Court in the scale of pay of ₹ 27800-59400 is provisionally promoted as Senior Grade Assistant, High Court in the scale of pay of ₹ 30700-65400 with effect from 06.04.2017 in the vacancy vice Smt. Ambili K. P., Senior Grade Assistant, High Court promoted as Assistant Section Officer, High Court as per the High Court proceedings read (2) above.

Sri. Shameer Babu S. Y., Senior Grade Assistant, High Court in the scale of pay of ₹ 30700-65400 is reverted as Assistant, High Court in the scale of pay of ₹ 27800-59400 w.e.f. 10.04.2017 F. N. in order to accommodate Sri. Girish K. Senior Grade Assistant, High Court who had been repatriated to High Court service as per the High Court proceedings read (3) above. He is reappointed as Senior

Grade Assistant, High Court, provisionally, w.e.f. 11.04.2017 in the first vacancy consequent on the refixation of cadre strength in the category of Senior Grade Assistant, High Court as per the High Court proceedings read (4) above.

Since the promotion granted to Sri. Shameer Babu S. Y., Assistant, High Court as Senior Grade Assistant, High Court is provisional, further promotions in the category of Senior Grade Assistant High Court are also made provisional.
