Judicial Department - Civil - Filling up the vacancies of Sheristadars and Senior Superintendents - Orders issued.

ORDER NO. B1 – 2935 / 2012(1)

As part of filling up the existing vacancies of Sheristadars of District Courts / Addl. District Courts / Motor Accidents Claims Tribunals / Spl. Courts and of Sheristadars of Sub Courts / Senior Superintendents of District Courts in the Civil Wing of the Subordinate Judiciary, the following orders are issued:

1. Shri P. Rajendran, Sheristadar, Sub Court, Karunagappally is promoted as Sheristadar, Addl. District Court / Motor Accidents Claims Tribunal / Spl. Court under Rule 4 (a) of the Kerala Judicial Ministerial Service Rules, 2006 and posted as Sheristadar, MACT, Perumbavoor. He will handover charge of his office to the Junior Superintendent / Head Clerk of the Court and take charge as Sheristadar, MACT, Perumbavoor from the Junior Superintendent / Head Clerk of the Tribunal.

He will handover charge of his office to the Junior Superintendent / Head Clerk of the Court and take charge as Senior Superintendent, District Court, Thrissur from Shri P.Santhoshkumar(SI.No.7)

The Junior Superintendent / Head Clerk of the Sub Court, Thrissur will hold the full additional charge of the post of Sheristadar of the Court till Sri.P. A. Anandakuttan (SI.No9) takes charge.

6. Smt. Saraswathy P., Sheristadar, Addl. Sub Court, Ernakulam is transferred and posted as Senior Superintendent, Addl. District Court, Mavelikkara. She will handover charge of her office to the Junior Superintendent / Head Clerk of the Court and take charge as Senior Superintendent, Addl. District Court, Mavelikkara from the Junior Superintendent/Head Clerk of the court

The Junior Superintendent / Head Clerk of the Addl. Sub Court, Ernakulam, will hold the full additional charge of the post of Sheridar, Addl. Sub Court, Ernakulam till Shri C.C.James(SI.No.8) takes charge.

7. Shri P. Santhoshkumar, Senior Superintendent, District Court, Thrissur is transferred and posted as Sheristadar, Sub Court, Neyyattinkara. He will handover charge of his office to Shri P.K.Muhammedali(SI.No.5) and take charge as Sheristadar, Sub Court, Neyyattinkara from the Junior Superintendent / Head Clerk of the Court on or after 1.11.2012.

8. Shri C.C.James, Junior Superintendent, MACT, Irinjalakuda is promoted as Sheristadar, Sub Court / Senior Superintendent, District Court under Rule 4 (a) of the Kerala Judicial Ministerial Service Rules, 2006 and posted as Sheristadar, Addl.Sub Court, Ernakulam. On relief from his present post, he will take charge as Sheristadar, Addl.Sub Court, Ernakulam from the Junior

Superintendent / Head Clerk of the Court.

Anandakuttan, Junior Superintendent, Munsiff's Court, Thrissur is promoted as Sheristadar, Sub Court / Senior Superintendent, District Court under Rule 4 (a) of the Kerala Judicial Ministerial Service Rules, 2006 and posted as Sheristadar, Sub Court, Thrissur. On relief from his present post, he will take charge as Sheristadar, Sub Court, Thrissur from the Junior Superintendent / Head Clerk of the Court.

10. Smt. T.E.Selma, Junior Superintendent, Munsiff's Court, Thodupuzha is promoted as Sheristadar, Sub Court / Senior Superintendent, District Court under Rule 4 (a) of the Kerala Judicial Ministerial Service Rules, 2006 and posted as Senior Superintendent, Special Court(NDPS Act cases), Thodupuzha. On relief from her present post, she will take charge as Senior Superintendent, Special Court(NDPS Act cases), Thodupuzha from the Junior Superintendent / Head Clerk of the Court.

11. Shri K.G.Muraleedharan, Junior Superintendent, District Court, Kollam is promoted as Sheristadar, Sub Court / Senior Superintendent, District Court under Rule 4 (a) of the Kerala Judicial Ministerial Service Rules, 2006 and posted as Sheristadar, Sub Court, Karunagappally. On relief from his present post, he will take charge as Sheristadar, Sub Court, Karunagappally from the Junior Superintendent / Head Clerk of the Court.

He will hand over charge of his office to the Junior Superintendent / Head Clerk of the Court on the A/N of 31-10-2012 on his retirement from service.



12. Shri A.T.Joseph, Sheristadar, Sub Court, Neyyattinkara is transferred and posted as Sheristadar, Sub Court, Karunagappally. He will handover charge of his office to Junior Superintendent /Head Clerk of the Court and take charge as Sheristadar, Sub Court, Karunagappally from the Junior Superintendent / Head Clerk of the Court on or after 01-11-2012.

The Junior Superintendent /Head Clerk of the Sub Court, Neyyattinkara will hold the full additional charge of the Sheristadar of the Court till Shri P.Santhoshkumar (Sl.No.7) takes Charge.

The officers at Sl. Nos. 5 & 6 are not eligible for joining time and for transfer TA. The Officer at Sl. No.2, 3, 4 & 12 are not eligible for joining time.
